Without sound management. co-ops often get into difficulty that threatens their survival. And if one co-op is lost, it's a loss to the entire co-op housing community.

That's why CHF Canada has declared 2012 the Year of Getting Management Right. And because 2012 is also the International Year of Co-operatives, now is a perfect time to emphasize the role management plays supporting the cooperative housing enterprises that provide our members with affordable, communityminded housing.

Good governance and management go hand in hand. At this year's CHF Canada Annual General Meeting in Niagara Falls, there are plenty of workshops to choose from in both the Member Education Forum and the Co-operative Management Conference. Boards need to know what sound management looks like, and how they can support and keep it. And co-op managers and staff can choose from topics that support them in the work they do. And remember that Management is one of the

standards of 2020 Vision, so look for the Management Standard workshop to help your co-op along the road to becoming a 2020 Co-op.

In 2004 the members of CHF Canada adopted five Core Management Standards that help measure and improve the quality of management in your co-op. no matter what kind of management you use. They are:

- Managing the finances
- Keeping the co-op in good repair
- Keeping the co-op full
- Meeting your legal requirements
- Supporting good governance.

To learn more about the Core Management Standards you can refer to Getting Management Right in the Resource Centre on our website. And throughout the year of Getting Management Right look for more resources and tools to be launched that support the Core Management Standards.

The 2011 national Good Governance Survey provided us with a great snapshot of the quality of governance in housing coops across the country, and a clear sense of where co-ops need more support. During the Year of Getting Management Right we would like to take the same kind of look at management in co-ops: members will be able to participate in a survey that will give a national overview of the state of management. Co-ops will also be able to take the test on their own to see how their individual management measures up. Look for the Sound Management Survey to be launched in the early spring: the results will be announced at the AGM, and shared with all members in NewsBriefs.

There's a lot more to come throughout the Year of Getting Management Right, and there are already many resources available in the CHF Canada Resource Centre, just go to the main page and follow the links to Managing Your Co-op. So start thinking about the value of sound management in your co-op, and look forward to a whole year of Getting Management Right.

MEMBER RIGHTS AND RESPONSIBILITIES: DID YOU KNOW? Article Source: Betty Jensen

1. YOU AND ALL MEMBERS HAVE THE RIGHT TO:

- peaceable possession of your assigned units and to personal privacy.
- participate in the operations, management and decision-making process of your co-op and to make decisions in the best interests of the whole co-operative.
- use an appropriate process to rsolve disputes with other members, the board or staff as described in co-op policy.
- decorate and make alterations to your unit as described in co-op policy
- Receive housing charge assistance if you are eligible and you receive board approval.

2. YOU AND ALL MEMBERS HAVE THE RESPONSIBILITY TO:

- comply with all the laws of the land and all co-op documents, contracts and policies.
- vote on the housing charge at a

- general membership meeting.
- submit your housing payment in advance of the 1st calendar day of each month and to make the amount payable on the 1st day of the month.
- pay a late penalty fee for each day you are in arrears starting at the end of the 1st calendar day of the month.
- make your housing payment by cheque, bank draft or money order.
- pay all charges as decided by the board.
- take care of the co-op's physical property as described in co-op policy.
- carry required insurance if you cannot live in your unit because of fire for example, you will not be asked pay your housing charge for the time of repairs or restoration, but you must pay for your own alternate accommodation.
- meet all legal and financial obligations of your membership in the co-op. All shareholders in your unit are together AND individually

- responsible for these obligations.
- give proper notice if you decide to leave the co-op - usually 2 clear calendar months' written notice.
- pay the housing charge for the required notice period even if you move out early.

3. THE CO-OP IS REQUIRED TO:

- follow the PIP Act (Personal Information Protection Act) regarding collection, use and retention of personal information.
- follow the specific process described in your co-op's by-laws and the Cooperatives Act if the board wants to consider terminating your membership and occupancy rights.
- invite you to meet with the board before they pass any motion of termination.
- 4. take care of the co-op's physical property as described in co-op policy.

Please take time to review your agreement.

YEAR OF THE CO-OP

The United Nations officially declared 2012 as the International Year of Co-operatives (IYC) on Thursday.

Live web casts were held out of Ottawa and Calgary to recognize co-ops around the world for the roles they play in their communities.

Launches were held at twelve locations across Alberta, one being at the Hi-Wood Meadows Housing Co-op (HMHC), a 62 unit co-op in High River.

Brenda Davies with the Southern Alberta Co-operative Housing Association (SACHA) says business and housing co-ops in towns are all part of one big community.

"We're all inter-connected and we all support each other," she says. The Hi-Wood Co-op belongs to SACHA and we belong to the Alberta Community and Co-operative Association and the Canadian Co-operative Association and we all support each other. It's a very large business model."

Doris McKay with the HMHC says they will be trying something new this year as part of the International Year of Co-operatives.

"We have talked about being a part of the trade fair when it's here in High River and setting up a booth and making people aware of the going on's of a co-op and what they mean and how they are run," says McKay.

Davies says the launch is a great way to spread the knowledge of co-ops to people who may not know the importance of them.

Several co-ops in High River are taking part in IYC including Servus Credit Union and the United Farmers of Alberta.



TWELVE WAYS YOU AND YOUR CO-OP CAN GET INVOLVED

- 1. Buy an IYC banner to hang on your building.
- 2. Start an IYC committee.
- 3. Put the IYC logo and slogan on your website, letterhead and emails.
- 4. Band together with other co-ops in your region to do something together.
- 5. Decide how you can partner with or support another coop for mutual benefit.
- 6. Organize a party or open house and invite neighbours, friends and elected representatives.
- 7. Investigate a new co-op each month, join at least one new co-op in 2012.
- 8. Ask your mayor to issue a declaration honouring IYC 2012.
- 9. Host a charitable event—
 show how co-operative
 enterprises do indeed build
 a better world.
- 10. Call on a local newspaper, radio or television station to do a feature on your co-op in light of IYC.
- 11. Post the seven co-op principles, review them at a members meeting, and discuss how your co-op could follow them more closely.
- 12. Offer to speak to a classroom, school or other group about your co-op, the co-op movement.
